Jessica Martin is the owner and instructor of Agile Dog Training located in Erin, Ontario. She has many years of experience training dogs of all breeds and competes against the best in the agility world each year.

Jessica's greatest accomplishment to date is winning the 2010 FCI World Championship in Germany with her young dog "Dice". She and Dice are currently the only Canadian team to have won this prestigious event. Dice has had tremendous success in her young career. She was part of the 2009 FCI World team in Austria, won the 2010 FCI World Championship in Germany, and was the 2011 Games Gold Medalist at the WAO in England.

Jessica's agility career began at the age of 14 when she got her first dog Mikki. Since then, Mikki and Jessica have become a very close team with many successes. These include winning the AAC National Championship 16" division in 2006 & 2009, the Ontario Regional Championship 16" division in 2008 and being part of the 2005, 2006 and 2007 FCI World Team. Jessica's second dog Kash completed her AAC ATChC in 4 months, at the age of 21 months, making her the youngest dog to obtain this title. She won the 2007 AAC Regional and National Championships 16" division and was the winner of the 16" division 2007 Royackers Canada Cup. Kash has also competed internationally, placing 2nd in the 2006 AKC Breed Invitational in Long Beach, CA. and being part of the 2008 FCI World Team. Her latest addition to her canine family is her border collie Heist who is already a superstar in his own puppyish way.

Jessica's goal as an instructor is to help every dog and handler team reach their full potential. Jessica has experience building confidence and motivation in the less driven or worried dogs and bringing out the best in them. Jessica has also worked with very intense, driven dogs and helped them gain consistency and control without diminishing speed. She believes the best agility dogs should be "balanced" in their skill sets. She promotes positive and motivational methods of training that are fun for the dogs and their handlers. Jessica's handling style promotes handler efficiency (getting you around the course faster!) while providing obvious physical and verbal cues for the dog.
